We depart Marshall, Michigan after breakfast, and continue our European Christmas Getaway with a visit to *Holland, Michigan's "Kerstmarkt"*, which is the Dutch language meaning "Christmas Market". We'll explore this delightful outdoor European-style market featuring Holiday items, local foods, artisan demonstrations and local products from Veldheer Tulip Farm, DeKlomp Delftware and Wooden Shoe Factory. Our European Christmas Get-A-Way continues as we travel to Frankenmuth, Michigan for our next two night stay at the beautiful Bavarian Inn Lodge. This afternoon a local guide joins us as we set our sights on exploring the traditions and culture that makes Frankenmuth a "Very Bavarian City". We'll visit the St Lorenz Church (subject to availability) and an opportunity to explore the world's largest Christmas store, *Bronner's Christmas Wonderland*. While at Bronner's, we will visit the *Silent Night Memorial Chapel*, a replica of a chapel in Salzburg, which marks the site where "Silent Night" was first sung in 1818. There will be free time during our stay to explore this quaint town of Frankenmuth with its European style shops, before return to our lodge to freshen up. This evening enjoy wine tasting with cheese and crackers and a family style Bavarian Christmas (three course meal) dinner with all the trimmings at the Bavarian Inn Restaurant.
